I also understand that, except as otherwise agreed to by MHT in writing, MHT does not assume any responsibility for or obligation to me to provide financial or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.
- 2. <u>Medical Treatment</u> Except as otherwise agreed to by MHT in writing, I hereby release and forever discharge MHT from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with my work for MHT.
- 3. <u>Assumption of the Risk</u> I understand that volunteering for MHT may include activities that may be hazardous or inherently dangerous to me. I hereby expressly and specifically assume the risk of injury or harm in these activities and release MHT from all liability for injury, illness, death, or property damage resulting from my activities in connection with services provided by MHT.
- 4. <u>Insurance</u> I understand that MHT does not carry, maintain or provide health, medical, or disability insurance coverage for any volunteer. Each volunteer is expected and encouraged to arrive for volunteer service with medical or health insurance coverage in effect.

Photographic Release I understand and agree that before, during and after the services and work provided as stated herein, I may be photographed and/or videotaped by MY HOMETOWN, its volunteers and partners for internal and/or promotional use. I hereby grant permission for them to do so and convey to MY HOMETOWN all right, title, and interest, including but not limited to, any royalties, proceeds, or other benefits, in any and all such photographs or video recordings, and consent to such parties' use of my name, image, likeness, and voice in perpetuity, in any medium or format, for any publicity, without further compensation or permission.
